

Cal MediConnect (CMC) Training Notice

Interdisciplinary Care Team (ICT) and Primary Care Physician Training

June 2, 2022

Dear Participating Provider Group,

This letter serves as an annual reminder to our previous communication in July, 2021, regarding the requirement that all Interdisciplinary Care Team (ICT) participants are required to complete training prior to participating as a member of the ICT or in an ICT meeting and within 365 days of a prior training. Per the Cal MediConnect Three Way Contract Section 2.5.2.8.8, all ICT members, and **potential** ICT members must be trained initially and on an annual basis. Because Primary Care Physicians are one of the required ICT participants, this training requirement extends to **all** network PCPs, regardless of their participation in ICT meetings. For your reference attached is **DPL 15-001**, Section B.2. indicates the composition of ICT and staff requirements. In Section B.4 we have highlighted that all **potential** ICT members be trained as part of delegation agreement.

As stated in previous communications, L.A. Care Health Plan requires all network PCPs and ICT members (**including potential**) to complete the ICT training on an annual basis and as on-boarded into your organization using training material provided by L.A. Care attached to this communication. Please submit confirmation(s) to L.A. Care's EPO SFTP site with screen shot of upload in an email to EPOCommunications@lacare.org once your full PCP network and appropriate staff have been trained. Training should occur no later than 30 days from receipt of this communication or within 365 days of last training.

L.A. Care will validate that PCPs and ICT members were adequately trained by reviewing submitted case files and requesting copies of signed attestations for those that are unverified.

L.A. Care will accept one of the following three forms of confirmation of training:

1. **Online via L.A. Care University** – For PPG staff only, reference the **Provider Network Instructions for Entering L.A. Care University**.
 - a. PCPs are not considered PPG staff
2. **Copy of signed attestation for PCPs**- From training document **ICT Training document and attestation** the last page is an attestation to be filled in by selecting edit document, entering requested information, signing and returning (scan/email).

3. **Copy of sign in logs or Webinar Report from Group training/Webinar** –showing attendees in addition to filling in the ***PPG Internal ICT Training Log.xlsx*** in electronic format as tracker for training and searchable document. For PCPs, NPI is a mandatory field.
